Learning objectives

- You develop an understanding of the institutional structure of the European Union, forms of political discourse, contents of political decision making in central fields, dynamics of transformation and their limits
- You understand analytical concepts of the transformation of states and integration in Europe
- You are be able to analyse decision-making processes of the European multilevel system by applying theoretical approaches.

Course content

The Russian attack on Ukraine and its consequences have reminded the European Union and its member states of the importance of the cornerstones of their cooperation. On the one hand, the peaceful resolution of conflicts cannot be taken for granted from a historical perspective, but requires constant political efforts. On the other hand, economic crises and high inflation clearly challenge the myth of the EU as a project of prosperity. These challenges come up against an EU that has already been confronted with multiple crises in the past decade (euro crisis, refugee crisis, rise of parties critical of the EU, Brexit, dismantling of democratic values in some member states, COVID-19 pandemic, systemic rivalry with China, as well as unresolved issues in relations with neighbouring states such as Switzerland and accession interests in south-eastern Europe). And at the same time, with its European Green Deal, the EU is putting together a comprehensive package of policy measures to respond to the major challenge of global climate change.

In order to understand how multiple crises and economic, geopolitical and socio-political challenges are dealt with in the European multi-level system, a basic knowledge of the interplay between actors and political institutions is indispensable. The development of such an empirical and analytical basic understanding through lectures and exercises is the central learning objective of the course. Thus equipped, the participants of the course are able both to critically engage with current developments and to form their own ideas about the development of the common future in Europe.

Examination content

There are two parts: an exam at mid-term (40%) and a final exam (60%)

The Examination at mid-term focuses on knowledge-based elements relating to the structure and functioning of institutions and key elements of discusses policy fields.

In addition to the knowledge-based component on other policy areas, the final Examination places particular emphasis on analytical skills.

Both the exam at mid-term and the final exam build on the mandatory readings, the lecture and the learning groups.
