Learn to

- execute challenging initiatives of transformational nature based on social impact measures, team process and effectiveness, and sustainability / ESG considerations,
- sharpen your ability to think strategically and to weigh things taking a long-term perspective, to ensure robust solutions that have a chance to be further developed by other participants in the foreseeable future,
- understand the requirements of shared leadership in a team with a diverse body of members, its impact on human interaction, and the necessary competencies and skills to become effective, and
- critically reflect your own mindsets, attitudes, and behaviours, by taking the posture of a true learner within the context of responsible global citizenship and diversity.

Course content

The SIMagination Challenge is an essential curricular pillar of the Master of Arts in Strategy and International Management (SIM-HSG). It intends to enable the participants to develop key leadership qualities, competencies and skills needed for tomorrow's global leaders. The year-long course is of explorative and experimental nature by approaching the relevant topic components in a practice mode. Students are in charge to independently plan, execute, and reflect upon a challenging international initiative of transformational nature which aims at leaving a positive and lasting social impact in our society.

This course provides students with a platform for reflecting on their own strengths and weaknesses, learning about transformation and how to cope with ambiguity, revisit their own habits and assumptions, challenge their mindsets, and reflect on the kind of leader they would like to become. As with the entirety of SIM, students' learning opportunities are dictated by the amount of effort they themselves invest in the course.

It remains the responsibility of the student and the student team to ensure that their initiative lives up to the course expectations. Need-based coaching provides structured feedback and opportunities for expert guidance.



A note on Environmental, Social and Governance (ESG): This course is dedicated for participants to develop and implement pragmatic approaches to concrete cases of environmental, social and governance challenges. The course addresses and proposes ways to reach the UN Sustainable Development Goals (SDG), net zero carbon emissions and other environmental targets, as well as allow participants to experience inclusive economic development.

Course structure and indications of the learning and teaching design

The course begins with the SIM gination Challenge Day on day 1 of the program, followed by a series of sessions and workshops in first term that form the foundation of the students' journey.

Besides sessions, the newly formed student teams will be coached and accompanied throughout the entire course duration until the SIMagination Reflection Day on the last day of the official course. Additionally, the teams will enjoy mentoring from the outgoing student generation and benefit from their experiences.

Thereafter, students prepare assignments individually as well as in teams and capture their legacy in handover documents for the next student generation to build on.

Course details including policies, grading, processes, deadlines and more are provided in the course handbook that is available for the students on CANVAS. The course handbook is binding for all students. In addition, updates and further information, including background information and literature sources, are shared on an ongoing basis and, in any case, available on CANVAS, as well.
